shall be comprised of THIRTY YEARS consecutively, to have commenced w.r.e.f. 01-08-1999 to 31-07-2029 which may be extended from time to time at the option of either parties hereto.

2. THE LESSEE herein shall pay and keep paying the aforesaid monthly rental of the property under lease @ Rs.100/- (One hundred rupees) to the LESSOR, positively, on or before 5th of every succeeding month.

3. THE LESSEE shall also pay and keep paying the entire power consumption and such other charges of maintenance of the premises under lease at its own costs during the subsistence of the said term of lease.

4. BY virtue of this instrument of lease, the LESSEE shall be entitled to continue to run its aforesaid institution of College of Education with any such of its other institutions affiliated to it from time to time, on the property under lease, during the currency of the above lease term.

5. FURTHERMORE, the LESSEE shall be at full liberty to avail any type of advancements/cash credit facilities/financial assistance from any of the financing institutions/agencies, scheduled or unscheduled Banks and etc., by creating any type of charge of mortgage on its lessehold rights over the property under lease.

6. IT shall always be lawful on the part of the LESSEE to keep the property under lease quite clean, tidy and always well maintained at its own costs while exercising authority from time to time during the subsistence of the lease term.


