- g) The profits if any shall not be distributed among members but to utilised for objects of the Society.
- h) The President/Secretary authorised to Registered the Society with the Registrar of Societies, Bidar with the R.S.R. Act 1950.

**RESOLUTION**

It is unanimously resolved that Sri. M.K. Narayan Swami B/o Bidar is President of the Society is fully authorised to transact all affairs and cash affairs of the Society and Secretary of the Society is authorised to correspond all the letters pertaining to the Society.

It is unanimously resolved to Register the Sri. Dattagiri Maharaj Education Society, Bidar with the registrar of Societies, Bidar and the newly formed by General Body and it is further resolved that the President/Secretary should be given authority to take steps to set up the society registered under the K.S.R. Act. 1960.

The Society having been formed mainly to further the object of facilitating the institutions and establishment of any institution where education could be imparted through any medium/type in the interest of and for the benefit of the community.

Lastly the following executive body members are elected in the meeting. The details are as shown below:

RULES AND REGULATIONS OF  
SRI DATTAGIRI EDUCATION SOCIETY, BIDAR

**1. Explanations:-**

- a) Society means: Sri Dattagiri Education Society, Vidyanagar Colony, BVB College Road, Bidar, Karnataka State.
- b) Institution means: Any institutions, established, run and maintained by Sri Dattagiri Education Society, Bidar.
- c) Body means: A body constituted under the provision valid of Rules and Regulations of the Sri Dattagiri Education Society, Bidar.
- d) General Body means: The body comprising of all the valid members of all categories under the rules and regulations of the Sri Dattagiri Education Society, Bidar.
- e) Executive body means: The Executive Body constituted by the General Body of the Sri Dattagiri Education Society, Bidar.
- f) Member means: A person who attain the age of 18 years and above enrolled as a member of the Society.

**2. Membership:-**

- a) Every member should strictly abide by the constitution, rules and regulations of the Society.
- b) Every member has the right to participate in all the activities of the Society in accordance with the constitution.
- c) Every member having sound mind of the age of 18 years and above and declared as a member of the Society has right to vote and who is not convicted for an offence of moral tripartite.
- d) Every member of the Society shall have the right of visiting and inspecting institutions of the Society and for making any suggestions that he may think proper.
- e) The application for membership shall be recommended by any two executive body members of the society, & approved the same.
- f) The membership shall be ceased or cancelled in case of death or involved in any crime or failed to pay membership fee or absent continuously 3 meetings or involve in illegal anti-maintenance activity.
- g) A person who contributed not less than Rs.100/- shall be member of the society and after declared as a member of the society who shall be pay Rs.50/- yearly (subject to enhancement of fees if required from time to time).

Members once who contributed the membership/donation is not refundable under any circumstances and also not entitle to transfer in the name of any other person. However, the General Body reserves the right either to accept or reject any body's membership in all the categories.

**3. General Body:-**

- General Body includes all the members of the Society:-
- a) At the beginning of the each financial year the general body shall approve and sanction of an account/funds for the year past in each of the Society's Institutions.
  - b) To appoint the executive body.
  - c) All questions before the meeting of the General Body of the Society shall be decided by majority of votes, the President having a casting vote, in case of equality of vote, in addition to his vote as a member.
  - d) The General Body shall have the power to bring or make any amendments to the existing rules and regulations of the Society.

- e) The quorum for General body meeting shall be the total number of members of the Society not less than 1/3rd of the total number of members of the Society shall form a quorum for the meeting of the General Body.
- g) The General Body meeting of the Society shall be held within one year by giving a clear fifteen days notice to all the members specifying the nature of business to be transacted, the date, time and place of the meeting.
- g) Accept as otherwise expressly provided herein, the whole administration, management and financial affairs of the Society shall rest in the executive body.

**4. Executive Body:-**

For the management of all matters connected with the Society there shall be Executive Body. The Executive body shall consist of 11 permanent members i.e. 1-President, 1-Vice President, 1-Secretary, 1-Vice Secretary, 1-Joint Secretary, 1-Treasurer and 3 other members.

- a) The office bearers of the executive body shall be elected at the end of every third year during the annual meeting of the Society. The same member being eligible for re-election of the office bearers.
- b) If during the three years tenure, owing to the death or resignation of any executive body member the vacancy thus created shall be filled up by the executive body from amongst the general body.
- c) It shall be the business of executive body:-
- i. To sanction any account/funds to current purposes.
  - ii. To call all the meetings. Subject to Sec. 11 of the K.R.A. 1960 there shall be an annual meeting of the General Body called as annual general body meeting every year which shall be convened to meet that year giving 15 clear days prior notice in writing to all the members of the Society.
  - iii. To start, maintain, run, affiliate or in-corporate any type of educational institutions at different places.
  - iv. To publish the annual reports and accounts of the Society.
  - v. To appoint an Auditor or Auditors for audit of Accounts. Subject to Sec. 13 of the K.S.R. Act, 1960, the executive body shall take all necessary steps to keep proper accounts of Income and Expenditure and Assets and Liabilities of the Society.
  - vi. To take every necessary legal step in the matter of Society.
  - vii. To represent the Society in its correspondence with Government or any other authority.
  - viii. The executive body shall have full access to the records of the Society's Institutions individually or collectively.
  - ix. The executive body exists for the special purpose of maintaining discipline and controlling education in the Society's Institutions. It shall make all appointments in the Society's Institutions, shall award punishments, shall dismiss, give promotions, direct transfers and reimbursements and granting leave and extension of service and any other matter relating to discipline and education. Its powers are absolute.
  - x. The rates of fees in Society/Institutions shall be fixed with the sanction of the executive body who shall also have full control over the all current funds.
  - xi. The executive body shall provide for the half-yearly inspection and also for annual inspection of the Society's institutions.
  - xii. There shall be four meetings of the executive body in a year.
  - xiii. All questions before the meeting of the executive body of the Society shall be decided by majority of votes, the President having a casting vote, in cases of equality of vote, in addition to his vote as a member.

- ix. It shall be duty of the executive body to arrange for the collection of funds for benefit of the Society.
- x. The question relating to discipline in the Institutions shall be absolutely in the hands of the Head of the Institutions who shall be strictly and directly responsible to the executive body.
- xi. Quorum:-

- a) Quorum for the executive body meeting if less than 1/3rd of the total number of members of the Society shall form a quorum for the meeting of the executive body.
- b) The quorum for ordinary meeting of the executive body shall consist of more than 50% of its members and there shall be no quorum for the adjourned meeting, if any ordinary meeting has to be adjourned for want of quorum.

### 3. Office bearers and their Powers:-

#### a) President:-

- i) The President shall be elected once in three years.
- ii) The President may call an urgent meetings with prior notice of 3 days in writing if there is an urgency.
- iii) The President shall be the Head of the Society and he shall be the over all management and its members.
- iv) In case of emergency take all such steps as may be required to safe guard the interest for the society and to report the same to the general body/executive body for its approval.

#### b) Vice-President:-

- i) The Vice-President shall be elected once in three years.
- ii) If the Presidentship becomes vacant/absent in the meeting in the middle of year the Vice-President shall act as President for the time being. But a meeting of the executive body members of the Society shall be summoned within two to four months for the election of a new President, and who shall assist the Preaddant.

#### c) Secretary:-

- i) The Secretary shall be elected once in three years.
- ii) It shall be duty of the Secretary of the Society to call all the meetings, to issue circulars, to correspond under the direction of executive body and to carry out their instructions.
- iii) To arrange for the election of the Society.
- iv) To prepare the agenda and to convene the meetings of the General/Executive body.

#### d) Vice-Secretary:-

- i) The Vice-Secretary shall be elected once in three years.
- ii) If the Secretary becomes vacant/absent the vice-Secretary shall act as Secretary shall act as Secretary for the time being.

#### e) Joint-Secretary:-

- i) The Joint-Secretary shall be elected once in three years.
- ii) The Joint-Secretary shall also assist the Secretary at head quarters in the matters the Society.

#### f) Treasurer:-

- i) The Treasurer shall be elected once in three years.
- ii) The Treasurer shall arrange to maintain/collect all accounts/ funds, receipts books like cash books, ledger and all documents records pertaining to the receipts and payment of the moneys including Bank Pass Book and cheques of the Society.

ii. He shall arrange to get the accounts of the society audited annually by such auditors who shall be a Chartered Accountant or Recognised Chartered Accountant approved by executive body.

6. Finance:-

- a) All the property and funds of the Society shall belong to the Society collectively. No individual member shall have any property/funds right over them.
- b) The financial resources for the objects and the activities of the society shall raised through:-
  - i) Donation from members and public.
  - ii) Loan and grant from the State/Central Government.
  - iii) Loan from Co-op. Banks, Schedule Banks, Nationalised Banks.
  - iv) Loan from members and any other local bodies.

7. Bank Account/s:-

All Bank Accounts/funds in the name of the Society shall be operated through cheques, draft with the Joint-signature of the President/Secretary and Treasurer of the Society.

8. Audit:-

The Accounts of the Society shall be audited by a recognised chartered accountant in every year and the audit report should be approved by the General Body. All the audit rectification shall be brought to the notice of the members by calling the general body or special general body and book reference should be made to the Chartered Accountant within 15 days after attending the audit rectification.

9. Annual returns:-

Annual returns should be filed in every year with the Registrar of Societies, Bidar in accordance with section 13 of the KSR Act, 1960.

10. Election of the Society:-

- a) The vote would be casted on secret ballot method.
- b) The election of the office bearers will be held in supervision of the Executive body members and advisors.

11. Amendment:-

- a) 2/3rd majority of the General Body can amend the constitution of the Society in a meeting.
- b) The amendment of the society shall be made in accordance with section 9 and 10 of the KSR Act, 1960. such amendments should be approved by the Registrar of Societies, Bidar before affecting it.

12. Dissolution of the Society:-

The Society shall only be dissolved or cancelled by 3/4th majority of the members present at a meeting specially convened for that purpose and resolution is passed to that effect. And the same shall be dissolved/cancelled or transferred to another Society, Trust Association etc.

13. Year of the Society:-

The year of the Society shall be 1st January to 31 st December.

14. Working hours of the Society:-
